5.1 CONSIDERATION OF APPLICATIONS:

5.2 TREASURERS REPORT:

MM presented the Treasurer's report, which included the following information: -

- Income for the first 9 months of the financial year, up to 31/12/2021 = £168,507.23;
- Total expenditure for the first 9 months of the financial year, up to 31/12/2021 (including grants totalling £107,761.18) = £191.51.32;
- The difference between income and expenditure for the first 9 months of the financial year, up to 31/12/2021 = -£22,544.09;
- Donations received (incl. the general public) = £2868.06;
- Donations received via 'Just Giving' = £596.71;
- Donations received via the collection boxes = £319.88; and
- The total monies in the charities bank accounts are currently £502,233.47.

7.1 <u>RETIRED OFFICERS – POTENTIAL DONATIONS POST RETIREMENT:</u>

GB suggested that the charity could consider inviting retired officers to donate the £1.50 regular subscription post retirement. Currently the subscription ceases when an officer retires, as a result of them no longer being in receipt of a wage from Police Scotland.

This suggestion received initial favourable consideration during discussions, including the potential for communication with officers immediately prior to them retiring to highlight the invitation / ability for them to continue to donate to the charity if they chose to do so.

GB was tasked with making further enquiries in relation to this subject with a view to the matter being discussed at the next BOT's meeting.
